ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 144/UT/RTI/FAA/SSP dated 14.12.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 04 points relating to Complaint No. PW2021-16987, 18696, 18562 i.e. Copy of complaints, Copy of enclosures, Copy of statements and copy of action taken report.

COMMENTS OF CPIO/South: -

CPIO/South submitted that application of the appellant was received online for supplying requisite information. Required information was obtained from SHO-49, who submitted that complaints in question are still under enquiry and the same has been denied u/s 8 (1) (h) of RTI Act. Appellant has been apprised vide memo no. 611/CPIO/South dated 29.11.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 04 points relating to Complaint No. PW2021-16987, 18696, 18562 i.e. Copy of complaints, Copy of enclosures, Copy of statements and copy of action taken report.

CPIO/South has denied the information to the appellant u/s 8 (1) (h) of RTI Act, as complaints are still under enquiry.

Insofar as appeal is concerned with point no. 01, CPIO/South is hereby directed to supply the copy of complaints and apprise about the status of complaints to the appellant.

With regard to point nos. 02, 03 & 04, information sought cannot be supplied at this stage as complaints are still under enquiry. Thus, CPIO/South has appropriately denied information u/s 08 (1) (h) of RTI Act.

With these directions, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
