### ORDER

The appellant has preferred 1st appeal against the reply/order of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 01/UT/RTI/FAA/SSP dated 06.01.2021 for further proceeding under RTI Act.

## INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought copy of compliant and its details regarding missing of his younger sister Priyanka lodged in PS-26 at around 01.10.2006 to 31.012.2006.

## COMMENTS OF CPIO/EAST: -

Comments of CPIO/East submitted that report from SHO-PS-26 has been obtained who submitted that record of that period has been destroyed

vide OB No. 72/2012 dated 29.03.2012, hence, requisite information is not available in record.

#### **DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought copy of compliant and its details regarding missing of his younger sister Priyanka lodged in PS-26 at around 01.10.2006 to 31.012.2006.

Insofar as appeal is concerned, it is clear from the reply of CPIO/East that record of that period has already been destroyed vide OB No. 72/2012, and not available in record. Thus, CPIO is not in position to supply the requisite information. However, copy of order vide which said record was destroyed, can be supplied at present.

Hence, CPIO/East is hereby directed to supply the copy of destroyal order, free of cost, forthwith. The instant appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
