ORDER

The appellant has preferred 1st appeal dated 18.06.2024 against the disposal of his RTI application dated 03.05.2024 by CPIO/Hqrs & South with the contentions that requisite information was not provided to him.

Information sought vide RTI application:-

The appellant vide his RTI application dated 03.05.2024 has sought information on 03 points i.e. status of complaint dated 03.10.2023 sent through registered post no. RP184711155IN, status of reminder sent through registered post no. EP516894870IN and copy of proceedings of complaint and reminder sent.

COMMENTS OF CPIO/Hgrs :-

CPIO/Hqrs vide his comments submitted that RTI application was received in his office to obtain information regarding complaint bearing No. ICMS/2023/026352. Thereafter, requisite information was obtained from I/C HAC who reported that complaint is consigned with HAC Branch and appellant was informed to collect the same. Thereafter, appellant visited the office of the under signed and after the inspection of the file, collected the requisite information in the shape of 25 pages vide letter No. 223/CPIO/Hqrs/RTI-2024 Dated 14.05.2024.

COMMENTS OF CPIO/South :-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his for supplying requisite information. Thereafter, requisite information was obtained from SHO PS-31, Chandigarh who reported that complaints bearing No. ICMS/2023/026579 & ICMS/2024/007057 are under enquiry and the same denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act. The appellant was informed accordingly vide letter No. 129/RTI-24/CPIO-South dated 15.05.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs & South vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 03 points i.e. status of complaint dated 03.10.2023 sent through registered post no. RP184711155IN, status of reminder sent through registered post no. EP516894870IN and copy of proceedings of complaint and reminder sent.

In reply, CPIO/Hqrs supplied the available information consisting of (25) pages to the appellant after arranging the inspection of the record and CPIO/South has denied the sought information to the appellant as complaints in question were under enquiry at that time.

Now as far as the appeal is concerned, CPIO/Hqrs has already provided the sought information to the appellant after providing him an opportunity of the inspection of the record, so, no more action is required to be taken on the part of CPIO/Hqrs. However, as per the record of ICMS portal, complaints bearing no. ICMS/2023/026579 & ICMS/2024/007057 have now been consigned with HAC Branch. Therefore, CPIO/South is hereby directed to provide the requisite information to the appellant as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
