ORDER

The appellant has preferred his 1st appeal through online RTI portal vide no. PODEP/A/E/22/00065 dated 12.06.2022, received on 13.06.2022 against the reply/order of CPIO/South in connection with his RTI application submitted through online RTI portal vide no. PODEP/R/E/22/00312 dated 06.05.2022 with the contention that incomplete and misleading information has been supplied.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant had sought information on 18 points regarding present status and action taken on two complaints bearing PWS No. 2022-07814 dated 13.04.2022 and 2022-08143 dated 20.04.2022 filed by him.

COMMENTS OF CPIO/North-East :-

Comments of CPIO/North-East have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide no. PODEP/R/E/22/00312 dated 06.05.2022 in which applicant sought information on 18 points regarding present status and action taken on two complaints bearing PWS Nos. 2022-07814 dated 13.04.2022 and 2022-08143 dated 20.04.2022 filed by him. Accordingly, report from SHO PS Manimajra was obtained who reported that the complaints in question were pending under enquiry, hence the information was denied u/s 8(1)(h) of RTI act and the appellant was informed vide letter no. 47/CPIO/North-East dated 10.05.2022.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant sought information pertaining to two complaints bearing PWS Nos. 2022-07814 dated 13.04.2022 and 2022-08143 dated 20.04.2022 filed by him. At the time of disposing of RTI application, the complaints in question were under enquiry and the information sought was rightly denied by CPIO/North-East u/s 8(1)(h) of RTI act. So far as present status of the complaints is concerned, as per record, the same are pending for final decision.

Hence, CPIO/North-East is directed to supply the requisite information to the appellant as per RTI act as and when the enquiry into the complaints is finalized. With this, instant appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
