ORDER

The appellant has preferred his 1st appeal through online RTI portal vide no. PODEP/A/E/22/00066 dated 13.06.2022 against the reply/order of CPIO/East in connection with his RTI application submitted through online RTI portal vide no. PODEP/R/E/22/00285/4 dated 25.04.2022 with the contention that the access to information requested have been refused.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide his RTI application dated 25.04.2022 had sought information on 18 points in connection with the investigation of case FIR No. 43/2020 PS 26 Chandigarh.

COMMENTS OF CPIO/East : -

Comments of CPIO/East have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide no. PODEP/R/E/22/00285/4 dated 25.04.2022 in which applicant sought information on 18 points in connection with the investigation of case FIR No. 43/2020 PS 26 Chandigarh. Accordingly, after obtaining the report from SHO PS-26 appellant was further informed vide letter no. 136-RTI/CPIO/East, dated 23.05.2022. Information on point No.s 1, 1A, 6 and 10B was supplied to the appellant, information on point Nos. 1B, 7 and 10A was denied u/s 8(1)(h) of RTI act as the case was under investigation, information on point Nos. 2, 2A, 3, 3A, 8A, 14A, 15 and 16 was denied being not found covered under purview of 2(f) of RTI act, information sought in point No. 9 was not clear hence not provided and information sought in point Nos. 4, 5, 8, 11, 12, 13, 14, 17 & 18 related to other CPIOs for which RTI application was already transferred to offices by Nodal officer PHQ Sector-9 Chandigarh..

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that the appellant vide his RTI application dated 25.04.2022 had sought information on 18 points in connection with the investigation of case FIR No. 43/2020 PS 26 Chandigarh i.e. status of case, role of investigation officer, what investigation have been made by various agencies of Chandigarh Police and what could have been done etc. As the available information (point wise) had already been provided by CPIO/East, thus, there was neither any delay nor any denial on the part of CPIO/East.

So far as appeal of the appellant is concerned, appellant has raised his grievances under the instant appeal. His grievances cannot be entertained under RTI Act as this act provides a mechanism for seeking information to the appellant but it is not an appropriate platform/forum for redressing his grievances. Whereas, CPIO/East had already furnished the points wise reply/information to the appellant, hence, no more action is warranted on the instant appeal and the same is hereby rejected and disposed of accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
