ORDER

The appellant has preferred his 1st appeal dated 18.03.2025 against the disposal of his RTI application dated 04.03.2025 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information in regard to complaint bearing No. PW-202024507 i.e. certified copy of complaint, action taken report alongwith statements of complaint.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from I/C HAC who reported that the record related to the sought complaint has already been destroyed after obtaining prior permission from the senior officers vide order No. F-307/2157-2207/UT/HAC dated 24.02.2025. On 17.03.2025, appellant was apprised about the same and a letter alongwith copy of destroy orders was supplied to the appellant by hand vide office letter No. 219/RTI-25/DSP/Admn dated 13.03.2025.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information in regard to complaint bearing No. PW-202024507 i.e. certified copy of complaint, action taken report alongwith statements of complaint.

In reply, CPIO/Admn has apprised the appellant that the record related to the sought complaint has already been destroyed and the copy of destroy orders were applied to the appellant.

Now as far as appeal is concerned, CPIO/Admn has already apprised the appellant the record related to the sought complaint has already been destroyed. Hence, no more action is required to be taken on this instant 1st appeal.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
