ORDER

The appellant has preferred her 1st appeal dated 28.03.2025 against the disposal of her RTI application dated 17.03.2025 by CPIO/South with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought information in regard to complaint bearing No. ICMS/2025/005950 i.e. Copy of complaint, documents attached, statements recorded etc.

COMMENTS OF CPIO/South :-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information. Thereafter, requisite information was obtained from SHO PS-49, Chandigarh who reported that complaint bearing No. ICMS/2025/005950 is under enquiry. Therefore, the requisite information cannot be provided to the applicant and was denied to the applicant as per the provisions section 8 (1) (h) of RTI Act. The appellant was apprised about the same through online RTI Portal vide office letter No. 42/RTI-25/CPIO-South dated 25.03.2025.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought information in regard to complaint bearing No. ICMS/2025/005950 i.e. Copy of complaint, documents attached, statements recorded etc.

In reply, CPIO/South had denied the requisite information as per the provisions of section 8 (1) (h) of RTI Act as complaint bearing No. ICMS/2025/005950 is under enquiry.

Now as far as the appeal is concerned, CPIO/South has appropriately disposed of the RTI application. However, copy of the complaint can be provided to the

applicant. Therefore, CPIO is hereby directed to provide the copy of complaint to the applicant, strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
