ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/21/00049 dated 21.06.2021) against the reply of CPIO/South in connection with his RTI application (bearing No. PODEP/R/E/21/00335 dated 13.06.2021) with the contentions that requisite information was not supplied to him. These appeals were diarized vide No. 54/UT/RTI/FAA/SSP dated 21.08.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant has sought information on 03 points pertaining to theft of Royal Enfield PB-13BG-5626 from H. No. 2603/C Block-18, Sector 63, Chandigarh.

COMMENTS OF CPIO/SOUTH: -

CPIO/South submitted that appellant has sought information through online RTI application. From perusal of RTI application, it found

that point No. 1 is related with CPIO/Communication and point no. 2 & 3 was denied u/s 8(1) (j) of RTI act as appellant has no concerned with the sought information,

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 03 points pertaining to theft of Royal Enfield PB-13BG-5626 from H. No. 2603/C Block-18, Sector 63, Chandigarh.

Insofar appeal is concerned, appellant has asserted that for settling the insurance claim of the stolen vehicle PB-13BG-5626, he has appointed Enquiry Officer by insurance company i.e. Reliance GIC. Considering his plea, CPIO/South is hereby directed to supply the requisite information to the appellant as per RTI Act after establishing the identity of the appellant. The appeal stands disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
