**ORDER**

\*\*\*\*\*

The appellant has preferred his 1<sup>st</sup> appeal on dated 23.06.2022 against the reply/order of CPIO/South and East in connection with his RTI application dated 20.05.2022 with the contention that requisite information was not supplied to him by both CPIOs.

**INFORMATION SOUGHT IN RTI APPLICATION :-**

The appellant vide his RTI application dated 20.05.2022 had sought information on 06 points concerning to DDR No. 04 dated 28.04.2022 PS Sector 19, Chandigarh.

**COMMENTS OF CPIO/South and East :-**

Comments of both the CPIOs i.e. South and East have been obtained. CPIO/South vide his comments submitted that the RTI application of the appellant received in his office through Public Window vide no. 427/RTI/CAPIO(PHQ)/UT/PWS dated 24.05.2022 and the appellant was informed vide letter no. 182/CPIO/South dated 10.06.2022 that the information sought does not relates to his office as the place of occurrence falls under the jurisdiction of PS Sector 19. In this context, the RTI application of the appellant was already transferred to CPIO/East by Incharge, Public Window-cum-CAPIO/PHQ.

CPIO/East submitted that the RTI application of the appellant received in his office through Public Window vide no. 427/RTI/CAPIO(PHQ)/UT/PWS dated 24.05.2022 for supplying information on 06 points concerning to DDR No. 04 dated 28.04.2022 PS Sector 19. Accordingly, after obtaining reply from SHO PS Sector 19, the same in point-wise form was sent to the applicant via registered post on 20.06.2022 which was returned undelivered on 23.06.2022 with the remarks that no one namely Vinod Kumar found residing at the given address.



**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South and East vis-à-vis material available on record which revealed that the requisite information had already been sent to the appellant at his given address by CPIO/East on 20.06.2022 but the same was returned undelivered on 23.06.2022 with the remarks that no one namely Vinod Kumar found residing at the given address. Moreover, requisite information was not found related to CPIO/South and the appellant was informed accordingly by him.

So, there is neither any delay nor any denial on the part of both the CPIOs. Hence, no more action is required to be taken on the instant appeal and the same is hereby stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
