ORDER

The appellant has preferred his 1st appeal dated 01.04.2025 against the disposal of his RTI application dated 12.03.2025 by CPIO/DCC with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information in regard to complaint bearing No. ICMS/2025/005009 i.e. current status of complaint, Stage at which the FIR process currently stands, Name & designation of Investigation Officer, Action taken etc.

COMMENTS OF CPIO/DCC :-

CPIO/DCC vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, the requisite information was obtained from I/C PO & Summon Staff and the same was provided to the appellant vide no. 03/RTI/CPIO/DCC dated 25.03.2025.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/DCC vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information in regard to complaint bearing No. ICMS/2025/005009 i.e. current status of complaint, Stage at which the FIR process currently stands, Name & designation of Investigation Officer, Action taken etc.

In reply, CPIO/DCC provided the available information obtained from quarter concerned to the appellant.

Now as far as appeal is concerned, the applicant has sought information regarding his complaint, which is still under consideration. Hence, the same cannot be

supplied to the applicant as per the provisions of section 8 (1) (h) of RTI Act. However, CPIO/DCC has inappropriately disposed of the RTI application without going through the contents of RTI Act. Therefore, CPIO is hereby directed to remain careful in future, while dealing the RTI and stick strictly to RTI Act and also provide the requisite information to the appellant if and when the complaint is filed, strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
