**ORDER**

The appellant has preferred 1<sup>st</sup> appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 151/UT/RTI/FAA/SSP dated 29.12.2020 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

The appellant had sought information/status report on 05 points pertaining to his complaints bearing No. 2020-15638, 2020-21303, 2020-16713, 2020-20075 & 2020-15638.

**COMMENTS OF CPIO/SOUTH: -**

Comments of CPIO/South has been obtained who submitted that complaint in questions i.e. 2020-15638, 2020-21303, 2020-16713, 2020-20075 & 2020-15638 were under enquiry at that time and the same were denied u/s 8(1) (h) of RTI Act vide letter No. 506-535/CPIO/South dated 26.12.2020.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 05 points pertaining to his complaints bearing No. 2020-15638, 2020-21303, 2020-16713, 2020-20075 & 2020-15638 i.e. status report along with endorsement.

Insofar as appeal is concerned, it is clear from the reply of CPIO/South that complaints in question are still under enquiry; therefore, the same cannot be supplied at this stage u/s 8(1) (h) of RTI Act.

However, considering that appellant is complainant in the aforementioned complaints and seeking status report of his complaints, hence, CPIO/South is hereby directed to brief the appellant regarding progress/status of his complaints. With these directions, instant appeal is hereby disposed of.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
