ORDER

The appellant has preferred his 1st appeal bearing dated 23.07.2024 against the disposal of his RTI application dated 05.07.2024 by CPIO/East with the contentions that requisite information was not provided to him.

Information sought vide RTI application:-

The appellant vide his RTI application has sought information on 03 points i.e. certified copy of complaint/statement of Anu, certified copy of statement of father of Anu and certified copy of statement of the undersigned.

COMMENTS OF CPIO/North-East :-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from SHO- Mani Majra and accordingly, copy of the DDR no. 86 dated 06.07.2024 was provided to the appellant, vide letter No. 81/RTI/CPIO/North-East dated 05.07.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/North-East vis-à-vis material available on record which revealed that the appellant vide his RTI application has sought information on 03 points i.e. certified copy of complaint/statement of Anu, certified copy of statement of father of Anu and certified copy of statement of the undersigned.

In reply, CPIO/North-East has provided the copy of the DDR to the appellant.

Now, as far as the appeal is concerned, appellant has raised contentions that only copy of DDR was provided and other documents i.e. copy of statements were not provided to him. Therefore, CPIO/North-East is hereby directed to provide the requisite information if available to the appellant strictly as per the provisions of the RTI Act,

after taking consent from the concerned parties. With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
