ORDER

The appellant has preferred 1st appeal on dated 21.06.2022 which were diarized vide this office no. 65/UT/RTI/SSP dated 14.06.2022 against the reply/order of CPIO/South-West in connection with his RTI application dated 26.05.2022 with the contention that requisite information was denied to him by CPIO.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide his RTI application dated 26.05.2022 had sought information on 5 points regarding DDR No.28 dated 07.01.2022 for 5pm to 8.30pm of Police Post ISBT-43 Chandigarh..

COMMENTS OF CPIO/South-West :-

Comments of CPIO South-West have been obtained who submitted that RTI application of the appellant was received in his office on 30.05.2022 through CAPIO PHQ vide his letter No. 451/RTI/CAPIO(PHQ)/UT/PWS, dated 26.05.2022 with the request to supply of information on 5 points regarding DDR No.28 dated 07.01.2022 for 5pm to 8.30pm of Police Post ISBT-43, Chandigarh. Accordingly, after obtaining information from SHO PS-36, the appellant was informed that the information sought cannot be provided being 3rd party and, thereby, denied u/s 8(1)(j) of RTI act vide letter No. 81-RTI/CPIO/South-West dated 11.06.2022.


DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South-West vis-à-vis material available on record which revealed that the appellant vide his RTI application dated 26.05.2022 have sought information on 5 points regarding DDR No.28 dated 07.01.2022 for

5pm to 8.30pm of Police Post ISBT-43, Chandigarh. In response CPIO/South-West vide letter dated 11.06.2022 informed the appellant that the information sought cannot be provided being 3rd party and denied u/s 8(1)(j) of RTI act. So far as grievances of the appellant raised in instant appeal are concerned, that cannot be entertained under RTI Act as this act provides a mechanism for seeking/providing information to the appellant but it is not an appropriate platform/forum for redressing his grievances.

Moreover, appellant has sought information of a DDR which relates to case FIR No. 56 dated 06.10.2021 u/s 419,420,467,468,471,201,204,120-B IPC and 66-D IT Act PS-19 Chandigarh and appellant is neither a complainant nor any alleged in this case. The said case is still under investigation, hence, the information sought was rightly denied by CPIO/ South-West, thus, no action is warranted in the instant appeal and the same stands disposed off, accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
