## ORDER

The appellant has preferred his 1<sup>st</sup> appeal dated 15.04.2025 against the disposal of his RTI application dated 28.03.2025 by CPIO/Admn & South with the contentions that requisite information was not provided to him.

# Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 05 points i.e. copy of report prepared by DSP/South for PCA complaint bearing No. 19/2019 sent to senior officers on 19.03.2025, Copy of FIR registered if any, Copy of relevant documents, Copy of Zero FIR if any and Copy of name of parents of Sarabjit Kaur as presented to the Chandigarh Housing Board by Kanwaljit Kaur.

#### COMMENTS OF CPIO/South :-

CPIO/South vide his comments submitted that the RTI application was received in his office to obtain the requisite information. Thereafter, pointwise reply was provided to the applicant through online RTI Portal vide office letter No. 62/RTI-25/CPIO-South/Chandigarh dated 11.04.2025.

### COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, the requisite information was obtained from I/C PCA, who reported that the complaint in question is under consideration. Hence, the sought information cannot be supplied to the appellant and was denied as per the provisions of section 8 (1) (h) of RTI Act. The appellant was apprised about the same through online RTI Portal vide No. 321/RTI/DSP/Admn dated 05.05.2025.

## **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South & CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 05 points i.e. copy of report prepared by DSP/South for PCA complaint bearing No. 19/2019 sent to senior officers on 19.03.2025, Copy of FIR registered if any, Copy of relevant documents, Copy of Zero FIR if any and Copy of name of parents of Sarabjit Kaur as presented to the Chandigarh Housing Board by Kanwaljit Kaur.

In reply CPIO/South has provided pointwise reply to the applicant and CPIO/Admn has denied the requisite information as per the provisions of section 8 (1) (h) of RTI Act.

Now as far as the appeal is concerned, complaint in question is still under consideration and requisite information cannot be provided at this stage also. Hence, denied as per the provisions of section 8 (1) (h) of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
