## ORDER

The appellant has preferred her 1<sup>st</sup> appeal dated 06.08.2024 against the disposal of her RTI application dated 19.07.2024 by CPIO/South with the contentions that requisite information was not provided to her.

# Information sought vide RTI application :-

The appellant vide her RTI application dated 19.07.2024 had sought information on 06 points regarding FIR No. 50 dated 16.04.2022 registered at PS-31, Chandigarh i.e. current status of FIR, Inquiry report of FIR, summons copies of FIR, copy of chargesheet report, case number details of FIR along with court order copy and Superdari details.

#### COMMENTS OF CPIO/South:-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO PS- 31 who reported that the FIR in question is still under investigation. Hence, the sought information was denied to the appellant as per the provisions of section 8(1) (h) of RTI Act, 2005. However, the copy of FIR was provided to the appellant. Applicant was apprised about the same vide letter No. 192/RTI-24/CPIO-South dated 30.07.2024.

### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought information on 06 points regarding FIR No. 50 dated 16.04.2022, PS-31, Chandigarh i.e. current status of FIR,

Inquiry report of FIR, summons copies of FIR, copy of chargesheet report, case number details of FIR along with court order copy and Superdari details.

In reply, CPIO/South has denied the requisite information U/s 8(1)(h) of RTI Act, as the matter pertains to investigation of case FIR No. 50 dated 16.04.2022 registered at Police Station- 31, Chandigarh and the same was under investigation at that time.

So far as present status of this case is concerned, the FIR in question is still under investigation and the sought information cannot be supplied at this stage also. Hence, the same is denied U/s 8(1)(h) of RTI Act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
