ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/A/E/21/00053 dated 10.07.2021) against the reply of CPIO/PHQ in connection with his RTI application (bearing No. PODEP/R/T/21/00376/1 dated 02.07.2021) with the contentions that requisite information was not supplied to him. These appeals were diarized vide No. 61/UT/RTI/ FAA/SSP dated 13.07.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant has sought copy of complete action taken report in complaint bearing No. 2021-07902 and copy of DDR No. 12 October, 2016 of PS-26 and copy of statement of accused Smt. Manisha.

COMMENTS OF CPIO/PHQ: -

CPIO/PHQ submitted that appellant has sought requisite information through online RTI application. After obtaining relevant

complaint file from HAC Branch, complainant was supplied requisite information containing 12 pages after inspecting the said complaint file.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought status & complete file of complaint bearing No. 2021-07902

Insofar appeal is concerned; it is clear from available record that requisite information including point No. 2 & 3 has already been furnished to the appellant by CPIO/PHQ after providing him opportunity of inspection of complaint file. Hence, no further action is warranted in the instant appeal, accordingly disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
