ORDER

The appellant has preferred his 1st appeal dated 08.06.2023 against the disposal of his RTI application dated 05.04.2023 by CPIO/South-West with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 05.04.2023 had sought information regarding complaint No. PW2021-09658 dated 10.05.2021 filed by the appellant against Mr. Raj Kumar Singal & others i.e. Complaint's complete correspondence file alongwith noting portion and statements of all persons, police officials, all enclosures etc.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office from I/C CAPIO/PHQ vide No. 286/RTI/CAPIO/PHQ/UT/PWS dated 11.04.2023 to obtain information regarding complaint No. PW2021-09658 dated 10.05.2021. Accordingly, requisite comments were obtained from I/C CRU who reported that complaint No. PW2021-09658 dated 10.05.2021 is under consideration for finalization, so the sought information was denied to the applicant as per provisions of section 8(1) (h) of RTI Act, 2005 vide letter No. 190/CPIO/Hqrs/RTI-2023/D-306 dated 19.04.2023.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that appellant had sought information regarding complaint No. PW2021-09658 dated 10.05.2021 filed by the appellant against Mr. Raj Kumar Singal & others i.e. Complaint's complete correspondence file alongwith noting portion and statements of all persons, police officials, all enclosures etc.

In reply, CPIO/Hqrs denied the requisite information to the appellant u/s 8(1) (h) of RTI Act as the compliant bearing No. PW2021-09658 dated 10.05.2021 was under enquiry at that stage.

So far as the appeal is concerned, the complaint in question has now been consigned to record after completion of enquiry. So, the available information in the record can be supplied to the appellant.

Resultantly, CPIO/Hqrs is hereby directed to supply the available information of the relevant complaint file to the appellant in accordance with RTI act.

With these observations, the instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
