**ORDER**

This is an order on the complaint/e-mail dated 18.10.2023 filed by the petitioner Mr. Surender Pal before the Hon'ble Chandigarh Right to Service Commission, UT Chandigarh with the allegations that Police Department UT Chandigarh is not taking action on his complaint dated 03.07.2023. The Hon'ble Commission vide order No. MS/CRTSC/2023/220 dated 07.11.2023 has referred the instant case to the undersigned for taking appropriate action.

**COMMENTS OF DESIGNATED OFFICER-CUM-SHO PS SECTOR 17:-**

Before proceeding further, comments of Designated Officer-cum-SHO PS Sector 17 has been obtained who submitted that the matter pertains to a complaint bearing No. ICMS/2023/016429 filed by the petitioner Mr. Surender Pal against Ms. Sapna Nanda and Mr. Mahender Singh which was received in his office for enquiry. During enquiry, statements of all parties were recorded, however, no cognizable offence was made out. Then after completion of enquiry the same is filed with HAC Branch.

**DECISION :-**


I have gone through the complaint of the complainant, instant petition of the petitioner, comments of Designated Officer-cum-SHO PS Sector 17 vis-à-vis material available on record thoroughly which revealed that the petitioner had filed a complaint vide No. ICMS/2023/016429 against Ms. Sapna Nanda and Mr. Mahender Singh for lodging FIR

against for committing various cognizable offence i.e. secretly making videos of girls/ladies while performing Yogasna.

As per comments of Designated Officer-cum-SHO PS Sector 17 and present status of the complaint it has been established that necessary/appropriate action has already been taken in the matter and complaint has already been filed with HAC Branch.

As complaint in question has already been disposed of, so no more action is required to be taken in the matter. However, in order to maintain the spirit of Right to Service Act, Designated Officer-cum-SHO PS 17 is hereby directed to strictly adhere to the provisions of Right to Service Act and complete the enquiry into complaints in a time bound manner as specified under Right to Service Act/Rules notified by Chandigarh Administration.
