ORDER

The appellant has preferred his 1st appeal dated 28.04.2025 against the disposal of his RTI application dated 22.03.2025 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 03 points regarding complaint bearing no. ICMS/2023/007134 i.e. name of I/O, designation of IO and address where complaint was marked.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that the RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC and on 05.05.2025, the same was supplied to the appellant through online RTI Portal vide office letter No. 296/RTI-25/DSP/Admn dated 05.05.2025.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 03 points regarding complaint bearing no. ICMS/2023/007134 i.e. name of I/O, designation of IO and address where complaint was marked.

In reply, CPIO/Admn has supplied point wise reply to the applicant.

Now as far as the appeal is concerned, CPIO/Admn has already provided the available information in point wise manner to the appellant. Hence, no more action is required to be taken on this instant 1st appeal.

However, from the perusal of the record in hand, it has been observed that there is delay in disposing of the RTI application. Therefore, CPIO/Admn is hereby advised to dispose of the RTI application within the stipulated time period and follow the provisions of RTI Act in its letter and spirit

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
