## THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-ACCOUNTS & PEB, UNDER RIGHT TO INFORMATION ACT, 2005.

## Order on First Appeal u/s 19 RTI Act.

This is an order on the online first appeal bearing No. PODEP/A/E/22/00020 dated 17.03.2022, preferred by Sh. Satpal r/o Village Humayupur, Tehsil and Distt Rohtak, Haryana, Pin:- 124406 under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System(RTI-MIS), against the disposal of his RTI Application dated 12.02.2022.

- (2) The appellant, vide his online application PODEP/R/E/22/00100 dated 12.02.2022 under RTI Act 2005, had requested Nodal Officer/PHQ, U.T., Chandigarh to supply him some information in 06 points related to Chandigarh Police duty deployed for elections in Pondicherry (known as Puducherry) in the year 2021. Nodal officer/PHQ had transferred the RTI application to CPIO/Accounts through online RTI Request & Appeal Management Information System (RTI-MIS) on 14.02.2022, for disposal at his own level. CPIO/Accounts, further disposed of the RTI application vide No. 16/RTI/CPIO (Accts)/2021/UT/6702 dated 04.03.2022 supplying part information on points No. 03 to 06 and also transferred the point No. 01 & 02 to CPIO/PEB, vide memo No. 16/RTI/CPIO (Accts)/2022/4662 dated 18.02.2022. CPIO/PEB has found that the information sought in point No. 01 & 02 is related to CPIO/IRB, Sarangpur and therefore he transferred the same to CPIO/IRB for its disposal at his own level being the custodian of the information sought in point No. 01 & 02.
- (3) The appellant is not satisfied with the information supplied to him, has filled instant appeal aggrieving that "the CPIO has provided incomplete information". The undersigned is the First Appellate Authority w.r.t. CPIO/Accounts & CPIO/PEB only. The comments of DSP-cum-CPIO/Accounts and CPIO/PEB have been called for.
- (4) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Accounts and CPIO/PEB. The appellant, through his RTI application, had sought information in 06 points, related to Chandigarh Police duty deployed for elections in Puducherry in the year 2021 and TA Allowance sanctioned to them for the duty. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-
