ORDER

The appellant has preferred 1st appeal against the reply of CPIO/PHQ in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 66/UT/RTI/FAA/SSP dated 22.07.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant had sought the statement of Mr. Ashok Gupta, DGM, Haryana recorded in complaint No. 2020-20923.

COMMENTS OF CPIO/PHQ: -

CPIO/PHQ submitted that appellant has sought information vide his RTI application. Thereafter, requisite information was obtained from I/C HAC Branch and appellant was informed that requisite information i.e. statement of Mr. Ashok Gupta, DGM, Harvana is not available in complaint bearing No. 2020-20923.

JECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/PHQ vis-à-vis material available on record which revealed that appellant had sought the statement of Mr. Ashok Gupta, DGM, Haryana recorded in complaint No. 2020-20923.

Insofar appeal is concerned, CPIO/PHQ has asserted that requisite information (i.e. statement of Ashok Kumar, DGM) is not available in the complaint file. On the other side, appellant has also asserted that statement of Mr. Ashok Kumar was recorded during the enquiry of complaint. Hence, CPIO/PHQ is hereby directed to once again thoroughly check the record of compliant file and if available, supply requisite statement to the appellant. With these directions, instant appeal is hereby disposed of, accordingly.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
