

**THE SENIOR SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE
AUTHORITY-ESTT. BRANCH, ACCOUNTS, RECRUTIMENT & PLWC
UNDER RIGHT TO INFORMATION ACT, 2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on an online First Appeal bearing no. PODEP/A/E/23/00009 dated 03/02/2023, preferred by Sh. Ram Kumar Garg R/o # 3328, Sector-27 D, Chandigarh, under RTI Act 2005, transferred to this office through online RTI Request & Appeal Management Information System (RTI-MIS) from the SSP/UT-cum-FAA, against the disposal of his online RTI Application bearing No. PODEP/R/E/22/00982 dated 13/12/2022 by several CPIOs, including CPIO/Establishment Branch, Accounts, Recruitment and PLWC.

(2) The appellant, vide his application dated 13/12/2022 under RTI Act 2005, had requested CPIOs to supply him some information in 05 points pertaining to Chandigarh Police. Nodal office PHQ had transferred the RTI application to CPIO/South Sub Division, Police Lines, Establishment Branch, Central Sub Division, South West Sub Division, East Sub Division, CCIC & MTMC Cell, North East Sub Division, Recruitment, PLWC and W&CSU for disposal at their own level being the custodian of the information sought in RTI application. The appellant is not satisfied with the manner CPIOs had disposed of his RTI application, filed the instant appeal alleging that reply to Point No.1 supplied partially as sale and Purchase data of GO Mess and Police Rest House Sector 26 for last three years not supplied. Only Sale Rates of Food items supplied Point No.2 No information supplied regarding Recruitment Fund and Band Fund. The undersigned is the First Appellate Authority w.r.t. CPIO/Establishment Branch, Accounts, Recruitment and PLWC only.

(3) The comments of CPIOs have been called for. I have gone through, information sought by the appellant, information supplied by the CPIOs and the ground of appeal. The points-wise decision of the undersigned being first appellate authority is as under:-
