ORDER

The appellant has preferred 1st appeals through online RTI portal vide No. PODEP/A/E/22/00081 dated 04.07.2022 against the disposal of her RTI application bearing No. PODEP/R/E/22/00405 dated 03.06.2022 by CPIO/South with the contentions that the requisite information was not provided to her.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide her RTI application dated 03.06.2022 had sought information/documents on 08 points referring to a complaint bearing PWS No.2022-09449 dated 05.05.2022 and also on 3 points pertaining to complaint bearing PWS No.2022-09878 dated 10.05.2022.

COMMENTS OF CPIO/South : -

Comments of CPIO/South have been obtained who submitted that RTI application of the appellant was received in his office from Nodal Officer RTI Cell PHQ Chandigarh on 04.06.2022 through online RTI portal vide No.PODEP/R/E/22/00405 dated 03.06.2022 to supply the part information pertaining to complaint bearing PWS No.2022-09449 dated 05.05.2022. The required information was obtained from SHO PS-34 who reported that regarding point No.1 of RTI application, complaint in question i.e. PWS No.2022-09449 dated 05.05.2022 received in his office through DSP/South on 10.05.2022 and information was denied u/s 8(1)(h) of RTI Act regarding point No. 2 to 8 of RTI application, being the same complaint

under enquiry. Point wise reply was sent to the appellant through e-mail vide letter No. 192/CPIO/South, dated 30.06.2022.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant vide her RTI application dated 03.06.2022 had sought point wise information pertaining to complaint bearing PWS No.2022-09449 dated 05.05.2022. Available information on point No.1 of RTI application was supplied to the appellant whereas information on point No.2 to 8 was rightly denied by CPIO/ South u/s 8(1)(h) of RTI as the complaint in question was under enquiry at that time. So far as the present status of this complaint is concerned, the same is still under enquiry.

Henceforth, CPIO/South is directed to supply the requisite information to the appellant as and when inquiry into the complaint bearing PWS no. 2022-09449 dated 05.05.2022 is finalized, **as per RTI act.**

With these directions instant appeal stands disposed of, accordingly.

In case, appellant is not satisfied with the disposal of her appeals, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
