

**THE SENIOR SUPERINTENDENT OF POLICE, HQs.- CUM-APPELLATE
AUTHORITY, COMMUNICATION, UNDER RIGHT TO INFORMATION ACT, 2005.**

ORDER

Order on First Appeal u/s 19 RTI Act.

This is an order on the online first appeal bearing PODEP/A/E/23/00018 dated 21/02/2023, preferred by Sh. Vizant Kumar R/o 174, Sector-30/A, Chandigarh under RTI Act 2005, received in this office through online RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his RTI Application bearing No. PODEP/R/E/22/00963 dated 03/12/2022.

2) The appellant, vide his RTI application dated 03/12/2022 under RTI Act 2005, had requested, RTI Nodal Officer/PHQ to supply him some information in 18 points w.r.t. action taken by Chandigarh Police against a call from his mobile No. 9023065195 to Police Helpline on 14.03.2021. Nodal Officer/PHQ has transferred the online RTI application to CPIO/Communication vide No. PODEP/R/E/22/00963, CPIO/East sub-division vide No. PODEP/R/E/22/00963/1 and CPIO/PCR vide No. PODEP/R/E/22/00963/2 for disposal at their own level. The undersigned is the First Appellate Authority w.r.t. CPIO/Communication only. CPIO/Communication has disposed off the RTI application, vide No. RTI-107/DSP/Comm./UT dated 08.12.2022.

3) The appellant, not satisfied with the manner in which his application was disposed off, has filed the instant appeal alleging that the original RTI request was forwarded by Chandigarh Police department to different CPIO's but all of them failed to give reply for the point no. 11 to 17 which is clear indication that department is not willing to provide the requested information and only re-routing the request to deny and mix the information. Also impartial reply for point no. 09 & 10 of the RTI application.

4) The comments of DSP-cum-CPIO/Communication have been called for. CPIO/Communication vide his comments has disclosed that out of 18 points only point No. 1, 2, 3, 4, 8 & part information on point No. 17 has been dealt by Communication Wing. But in present appeal the appellant is not satisfied with the reply given on point no. 11 to 17 and also with the impartial reply for point no. 09 & 10 which were related to CPIO/PCR and CPIO/East Sub Division. However, part information on point No. 17 is already supplied by their office to the applicant.

5) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Communication. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-



6) The appeal against point No. 17 is hereby disposed of.

7) The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
