**ORDER**

The appellant has preferred 1<sup>st</sup> appeal against the reply/order of CPIO/South in connection with his RTI application with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 146/UT/RTI/FAA/SSP dated 21.12.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

The appellant had sought copy of status & enquiry report and statements of accused and other witness recorded in DDR No. 32 dated 18.12.2019 lodged at PP-43, Chandigarh.

**COMMENTS OF CPIO/South : -**

Comments of CPIO/South submitted that report from SHO-36 has been obtained who submitted that applicant did not mention her relation/concern with the above said matter. Hence, denied being a third party information u/s 8 (1) (j) of RTI Act. Applicant has been apprised about the same vide no. 633/CPIO/South dated 10.12.2021.

Moreover, the requisite information was supplied to the appellant in respect of another RTI application dated 20.12.2021 vide letter no. 646/CPIO/South dated 30.12.2021 regarding same DDR no. 32 dated 18.12.2019 sought information has been supplied to the applicant.

**DECISION :-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought copy of status and statements of accused and other witness recorded in DDR No. 32 dated 18.12.2019 lodged at PP-43, Chandigarh.

In reply, CPIO/South had inappropriately denied the requisite information u/s 8 (1) (j) of RTI act. Hence, CPIO/South is hereby directed to supply the requisite information to the applicant as per RTI Act. Appeal stands disposed of accordingly.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
