<u>ORDER</u>

The appellant has preferred online 1st appeal bearing No. PODEP/A/E/23/00055 dated 03.07.2023 against the disposal of his online RTI application bearing No. PODEP/R/E/23/00451 dated 29.05.2023 by CPIO/Hqrs with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application dated 29.05.2023 had sought information pertaining to complaint No. ICMS/2022/000957 dated 20.06.2022 i.e. copy of complaint and action taken report/enquiry report.

COMMENTS OF CPIO/Hgrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to obtain the information regarding complaint No. ICMS/2022/000957. Accordingly, requisite information was obtained from I/C CRU, who reported that complaint in question, is still under consideration/enquiry for finalization. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 173/CPIO/Hqrs./RTI-2023/D-133 Dated, Chandigarh the: 23.06.2023. The complaint in question is still under consideration.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information pertaining to complaint No. ICMS/2022/000957 dated 20.06.2022 i.e. copy of complaint and action taken report/enquiry report.

In reply, CPIO/Hqrs had denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the complaint in questions was under enquiry at that stage.

So far as the instant appeal is concerned, as per record of ICMS portal, the above said complaint (ICMS/2022/000957) has now been consigned to record after completion of enquiry/finalization. Hence, the complete documents/information can be supplied to the appellant. Therefore, CPIO/Hqrs is hereby directed to provide the requisite information to the appellant in accordance with RTI act.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
