ORDER

This is an order on the complaint/petition dated 14.10.2024 filed by the petitioner Ms. Sudershan Anand & Mr. Deepak Kumar before the Hon'ble Chandigarh Right to Service Commission, UT Chandigarh with the allegations for taking appropriate action upon the application. The Hon'ble Commission vide order No. MS/CRTSC/2023/220 dated 14.10.2024, has referred the instant case to the undersigned for taking appropriate action.

COMMENTS OF DESIGNATED OFFICER-CUM-SHO PS 17:-

Before proceeding further, comments of Designated Officer-cum-SHO PS-17 has been obtained who submitted that the matter pertains to complaint bearing No. ICMS/2024/026372 and many others filed in the same matter by the petitioner Ms. Sudershan Anand against Mr. Rajan, Mr. Jhumru and Mr. Ghanshyam (Showroom owner) regarding outstanding wages of Mr. Deepak Kumar alongwith threats to kill him & filing false case. During enquiry, statements of Ms. Sudershan Anand & Mr. Deepak Kumar were got recorded, wherein they stated that their matter has been resolved and both the parties have come to a mutual compromise and requested to close all their complaints. Accordingly, final enquiry report along with relevant documents of all complaints was sent to senior officer.

DECISION:-

I have gone through the complaints as well as instant petition, comments of SHO-17, Chandigarh vis-à-vis material available on record thoroughly which revealed that the petitioner had filed complaints against Mr. Rajan, Mr. Jhumru and Mr. Ghanshyam (Showroom owner) alleging outstanding wages of Mr. Deepak Kumar alongwith threats to kill him & filing false case.

As per comments of Designated Officer-cum-SHO -17 submitted that the matter has been resolved amicably and a mutual compromise has been affected between the parties and complainant requested to close all their complaints in this matter. Accordingly, all complaints in question were sent to senior officers after enquiry.

In view of above facts and circumstances, it is clear that matter has been resolved amicably and a mutual compromise has been affected between the parties. Ms. Sudershan Anand & Mr. Deepak Kumar in their written statement stated to close all their complaints in this matter. However, in order to maintain the spirit of Right to Service Act, Designated Officer-cum-SHO PS-17 is hereby directed to strictly adhere to the provisions of Right to Service Act and complete the enquiry into complaints in a time bound manner as specified under Right to Service Act/Rules notified by Chandigarh Administration.

With these observations, instant petition stands disposed off, accordingly
