**ORDER**

The appellant has preferred 1<sup>st</sup> appeal (bearing No. PODEP/A/E/21/00058 dated 03.08.2021) against the reply of CPIO/South in connection with his RTI application (bearing No. PODEP/R/E/21/384/1 dated 06.07.2021) with the contentions that requisite information was not supplied to him. These appeals were diarized vide No. 74/UT/RTI/FAA/SSP dated 03.08.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

The appellant has sought information on 07 points on various issues i.e. copy of compromise, between Kanwaljit Kaur & Kanwar N. Singh, detail of complaints against owner of # 3589 sector 46, copy of closer report forwarded to Punjab Police etc.

**COMMENTS OF CPIO/SOUTH: -**

CPIO/South submitted that appellant has sought information through online RTI application. After obtaining requisite information from

SHO/PS-34, points wise available record were provided to the appellant vide No. 356/CPIO/South dated 02.08.2021.


**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that appellant had sought information on 07 points on various issues i.e. copy of compromise, between Kanwaljit Kaur & Kanwar N. Singh, detail of complaints against owner of # 3589 sector 46, copy of closer report forwarded to Punjab Police etc.

Insofar appeal is concerned; appellant has raised his grievances which cannot be redressed under the RTI Act, as RTI Act is the platform for furnishing available information to the appellant. Moreover, from the reply of the CPIO/South, it is clear that available information has already been furnished to the appellant but still appellant is not satisfied with that, hence, CPIO/South is hereby directed to provide the opportunity of inspection of available record accordingly supply the information to the appellant, if any he requires.

In terms of above, appeal stands disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
