ORDER

The appellant has preferred his 1st appeal dated 05.05.2025 against the disposal of his RTI application dated 27.03.2025 by CPIO/South with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide her RTI applications had sought information regarding FIR no. 171 dated 31.08.2024 registered at PS-31, Chandigarh i.e. copy of every letter /reply submitted by accused, copy of letter sent by IO to Cyber Crime Cell, copy of any reply received by IO, copy of communication/reminder received from complainant, noting/notes in case FIR, copy of communication by IO to GMADA or banks, copy of reply received from GMADA or banks and copy of legal opinion etc.

COMMENTS OF CPIO/South :-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from SHO PS-31, Chandigarh who reported that case FIR no. 171 dated 31.08.2024 registered at PS-31, Chandigarh is under investigation. Hence, sought information was denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act and the reply was sent to the applicant vide letter No. 56/RTI/CPIO-South/Chandigarh dated 25.04.2025.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information regarding FIR no. 171 dated 31.08.2024 registered at PS-31, Chandigarh i.e. copy of every letter /reply submitted by accused, copy of letter sent by IO to Cyber Crime Cell, copy of any reply received by IO, copy of communication/reminder received from complainant, noting/notes in

case FIR, copy of communication by IO to GMADA or banks, copy of reply received from GMADA or banks and copy of legal opinion etc.

In reply, CPIO/South has denied the requisite information to the applicant, as per the provisions of section 8 (1) (h) of RTI Act.

Now as far as appeal is concerned, CPIO/South has appropriately disposed of the RTI application as case FIR No. 171 dated 31.08.2024 u/s 420, 120-B IPC, PS-31, is still under investigation. Therefore, requisite information cannot be provided at this stage also.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
