ORDER

The appellant has preferred 1st appeal against the reply of CPIO/East in connection with his RTI application with the contentions that requisite information was not supplied to him. The appeal was diarized vide No. 75/UT/RTI/FAA/SSP dated 04.08.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

The appellant has sought CCTV footage of Police Post BDC for dated 10.07.2021 during the time period 2.50 to 03.30 etc.

COMMENTS OF CPIO/EAST: -

CPIO/East submitted that appellant has sought information Through RTI application. Thereafter, requisite CCTV footage was preserved from I/C Wireless Workshop. But SHO/PS-26 had denied to disclose the


CCTV footage by applying section 8(1) (g) & (h) of RTI Act as such CCTV footage may contain personal information of complainants, informers etc.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant had sought CCTV footage of Police Post BDC for dated 10.07.2021 during the time period 2.50 to 03.30 etc.

Insofar appeal is concerned, appellant wants CCTV footage dated 10.07.2021 of PP-BDC from 2.50 PM to 03.30 PM. CPIO/East has denied the requisite information by applying section 8(1)(g) & (h) of RTI Act. In the present appeal, by using the severability provision of section 10 of RTI Act, relevant portion of the CCTV footage can be severed which is directly related with appellant and not attracted exemption clauses of Section 8 of RTI Act. Hence, CPIO/East is hereby directed to carefully watch the CCTV footage of Police Post-BDC and if the same is not attracted the section 8(1)(g) & (h) of RTI Act, then supply the relevant portion of CCTV footage to appellant, free of cost, as per RTI Act.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
