The appellant has preferred 1<sup>st</sup> appeal on 04.07.2022 against the reply/order of CPIO/Hqrs in connection with his RTI application dated 26.05.2022, received on 01.06.22 with the contention that requisite information was denied to him .

**INFORMATION SOUGHT IN RTI APPLICATION :-**

The appellant vide his RTI application dated 26.05.2022 had sought information on several points relates to service records like appointment, suspension, re-instatement, promotion, increments etc. of Inspector Paramjit Kaur Sekhon. The RTI application was transferred to CPIO/Hqrs by CPIO/Establishment only with regard to point nos. 3 to 5 i.e. suspension orders, suspension revoked orders and re-instate orders etc.

**COMMENTS OF CPIO/Hqrs :-**

Comments of CPIO/Hqrs have been obtained who submitted that RTI application of the appellant was transferred to his office by CPIO/Establishment, PHQ Chandigarh vide letter no. 83/RTI-2022/CPIO/Estt./UT/25553 dated 01.06.2022 to supply the information on para nos. 3 to 5 of RTI application. As the information was related to service records like appointment, suspension, re-instatement, promotion, increments etc. of Inspector Paramjit Kaur Sekhon. So, as per provisions of section 11 of RTI Act, consent of Insp. Paramjit Kaur Sekhon was obtained

Moreover, disclosure of sought information has no relationship to any public activity or interest so, keeping in view the provisions of section 11 of RTI act and written submission of Insp. Paramjit Kaur Sekhon, the requisite information was denied u/s 8(1)(j) of RTI act vide letter no. 297/CPIO/Hqrs/RTI-22/D-573 dated 28.06.2022.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the RTI application of the appellant was transferred by CPIO/Estt. to CPIO/Hqrs for providing partial information on para no. 3 to 5 related to service records of Inspector Paramjit Kaur Sekhon i.e. suspension orders, suspension revoking orders, re-instatement orders etc.

In reply, CPIO/Hqrs, after taking consent of Insp. Paramjit Kaur Sekhon u/s 11(1) of RTI Act, rightly denied the requisite information u/s 8(1)(j) of RTI act. Moreover, disclosure of sought information has no relationship to any public activity or interest. Hence, no more action is required to be taken on the instant appeal and the same is hereby disposed of as dismissed.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
