**ORDER**

The appellant has preferred her 1<sup>st</sup> appeal dated 10.05.2025 against the disposal of her RTI application dated 05.04.2025 by CPIO/Admn with the contentions that requisite information was not provided to him.

**Information sought vide RTI application :-**

The appellant vide her RTI application had sought copy of inquiry report in regard to complaint bearing no. ICMS/2023/013791.

**COMMENTS OF CPIO/Admn :-**

CPIO/Admn vide his comments submitted that the RTI application was received in his office to obtain the requisite information. Thereafter, requisite information was obtained from I/C HAC and on 13.05.2025, the same was supplied to the appellant through online RTI Portal vide office letter No. 337/RTI-25/DSP/Admn dated 13.05.2025.

**DECISION :-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought copy of inquiry report in regard to complaint bearing no. ICMS/2023/013791.

In reply, CPIO/Admn has supplied the available information to the appellant through online RTI Portal vide office letter No. 337/RTI-25/DSP/Admn dated 13.05.2025.

Now as far as the appeal is concerned, CPIO/Admn has already provided the available information to the appellant. Hence, no more action is required to be taken on this instant 1<sup>st</sup> appeal.



However, from the perusal of the record in hand, it has been observed that there is delay in disposing of the RTI application. Therefore, CPIO/Admn is hereby advised to dispose of the RTI application within the stipulated time period and follow the provisions of RTI Act in its letter and spirit.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
