ORDER

The appellant has preferred her 1st appeal dated 16.08.2024 against the disposal of her RTI application dated 14.07.2024 by concerned CPIOs with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application had sought complete copy of reports sent in the end of April/2024 beginning of May/2024 by SDPO/East to SSP, Chandigarh against reports having no. 07-5 Parole dated 18.04.2024 regarding pre-mature release of Ravdeep Kaur R/o H. No. 159. Sector 20-A, Chandigarh.

COMMENTS OF CPIO/East:-

CPIO/East vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Accordingly, requisite information was obtained from SHO-19 who reported that enquiry into pre-mature release was conducted and after verification the same was sent to senior officers. RTI application was also transferred to CPIO/Hqrs vide no. 126-RTI/CPIO/East dated 27.07.2024 and applicant was apprised, accordingly.

COMMENTS OF CPIO/Hqrs:-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from I/C HAC who reported that record of pre-mature release of Ms. Ravdeep Kaur is now consigned with HAC Branch and the same was supplied to the appellant in the shape of 02 pages vide no. 203/CPIO/Hqrs/Online RTI-24, D-158 dated 22.08.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of concerned CPIOs vis-à-vis material available on record which revealed that


the appellant vide his RTI application had sought complete copy of reports sent in the end of April/2024 beginning of May/2024 by SDPO/East to SSP, Chandigarh against reports having no. 07-5 Parole dated 18.04.2024 regarding pre-mature release of Ravdeep Kaur R/o H. No. 159, Sector 20-A, Chandigarh.

In reply, CPIO/Hqrs has supplied the sought information to the appellant in the shape of (02) pages vide no. 203/CPIO/Hqrs/Online RTI-24, D-158 dated 22.08.2024.

Now as far as the appeal is concerned, CPIO/Hqrs has already provided the available information to the appellant in the shape of (02) pages. Hence, no more action is required on this first appeal.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
