**ORDER**

The appellant has preferred his 1<sup>st</sup> appeal through online RTI portal vide No. PODEP/A/E/22/00091 dated 05.08.2022 against the disposal of his RTI application bearing No. PODEP/R/E/22/00471 dated 24.06.2022 by CPIO/Central with contentions that the requisite information was refused to him.

**INFORMATION SOUGHT IN RTI APPLICATION :-**

The appellant vide his RTI application bearing no. PODEP/R/E/22/00471 dated 24.06.2022 had sought copy of Power of Attorney by Ms. Shalini Sharma, Power of Attorney by Mr. Tarun Ahuja and Gift Certificate in complaint no. PW 2019-19815 dated 16.10.2019.

**COMMENTS OF CPIO/Central :-**

Comments of CPIO/Central have been obtained who submitted that the RTI application of the appellant was received in his office through online RTI portal vide No. PODEP/R/E/22/00471 dated 24.06.2022 to supply copy of Power of Attorney by Ms. Shalini Sharma, Power of Attorney by Mr. Tarun Ahuja and Gift Certificate in complaint bearing PWS No. 2019-19815 dated 16.10.2019. The requisite information was obtained from SHO PS-17, who reported that the copy of power of attorney by Ms. Shalini Sharma, copy of power of attorney by Mr. Tarun Ahuja and copy of gift certificate were not available

in file of complaint No. PW 2019-19815. This information was conveyed to the appellant vide letter No. 189/RTI-22/CPIO-Central dated 18.07.2022. Moreover copy of one special power of attorney given by appellant Sanjeev Joshi in favour of Tarun Ahuja found attached with above said complaint and same is also appended with the comments.

**DECISION :-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that the information sought by the appellant vide his RTI application dated 24.06.2022 i.e copy of power of attorney by Ms. Shalini Sharma, copy of power of attorney by Mr. Tarun Ahuja and copy of gift certificate not found exists in the file of complaint bearing PWS No. 2019-19815 dated 16.10.2019 and information in this regard has already been conveyed to the appellant by CPIO/Central vide letter No. 189/RTI-22/CPIO-Central dated 18.07.2022. As the available information has already been provided by the CPIO, thus, there was neither any delay nor any denial on the part of CPIO/ Central. Moreover, copy of one special power of attorney given by appellant Sanjeev Joshi in favour of Tarun Ahuja found attached with complaint bearing PWS No. 2019-19815 and the same is enclosed herewith for the satisfaction of the appellant.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of this appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
