## ORDER

The appellant has preferred his 1<sup>st</sup> appeal dated 09.05.2025 against the disposal of his RTI application dated 07.04.2025 by CPIO/South with the contentions that requisite information was not provided to him.

# Information sought vide RTI application :-

The appellant vide his RTI application had sought pointwise information regard to complaint bearing no. ICMS/2025/006561 i.e. current status of complaint, detail of investigation conducted, any correspondence or communication sent regarding this complaint, department handling this complaint alongwith name of investigation officer and copy of reports or records in regard to the said complaint.

## COMMENTS OF CPIO/South :-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, the requisite information was obtained from SHO PS-34, Chandigarh who reported that the complaint in question is under inquiry. Hence, the sought information was denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act. However, information related to point no. 4 was provided to the appellant. The reply was sent to the applicant vide letter No. 71/RTI-25/CPIO-South dated 25.04.2025.

#### **DECISION:-**

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/South vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought pointwise information regard to complaint bearing no. ICMS/2025/006561 i.e. current status of complaint, detail of investigation conducted, any correspondence or communication sent regarding this complaint, department handling this complaint alongwith name of investigation officer and copy of reports or records in regard to the said complaint.

In reply, CPIO/South has denied the requisite information to the applicant, as per the provisions of section 8 (1) (h) of RTI Act. However, information related to point no. 4 was provided to the appellant.

Now as far as appeal is concerned, CPIO/South has appropriately disposed of the RTI application under the provision of section 8 (1) (h) of RTI Act, as the complaint in question is still under inquiry. Therefore, requisite information cannot be provided at this stage also.

However, appellant has raised contentions that he has not received reply on his RTI application, but CPIO has iterated that reply has already been sent through registered post. Therefore, applicant is hereby advised to collect the same from the office of concerned CPIO at any time, if reply is not received through registered post and CPIO/South is hereby directed to provide the same to the applicant, if he approaches the office of CPIO.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
