ORDER

The appellant has preferred instant 1st appeal through online RTI portal vide No. PODEP/A/E/22/00092 dated 07.08.2022 against the disposal of his RTI application bearing No. PODEP/R/E/22/00484 dated 30.06.2022 by CPIO/Hqrs with the contentions that the requisite information was not provided to him.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide his RTI application dated 30.06.2022 had sought information/documents pertaining to two complaints bearing PWS No.2020-18346 and PWS No.2021-19356.

COMMENTS OF CPIO/Hgrs.: -

Comments of CPIO/Hqrs. have been obtained who submitted that RTI application of the appellant was received in his through online RTI portal vide No. PODEP/R/E/22/00484 dated 30.06.2022 to supply the information pertaining to two complaints bearing PWS No.2020-18346 and PWS No.2021-19356. The required information was obtained from I/C CRU who reported that "both these complaints are under consideration with senior officer", hence, the information sought by the appellant was denied u/s 8(1)(h) of RTI Act vide letter No. 175/CPIO/Hqrs/Online, RTI-22,D-119, dated 02.08.2022.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs. vis-à-vis material available on record which revealed that appellant vide his RTI application No. PODEP/R/E/22/00484 dated 30.06.2022 had sought information pertaining to two complaints bearing PWS No.2020-18346 and PWS No.2021-19356. At that time both these complaint were under consideration, so Information sought by the appellant was rightly denied by CPIO/Hqrs u/s 8(1)(h) of RTI Act.

So far as the present status of these complaints is concerned, inquiry into these complaints is being conducted collectively and the same is yet to be finalized. Moreover the matter is being examined legally, hence, the Information sought by the appellant cannot be supplied at this stage and denied u/s 8(1)(h) of RTI Act.

However as appellant is the complainant in these complaints and for his satisfaction, CPIO/Hqrs is directed to supply the requisite information to the appellant as and when inquiry into the complaints bearing PWS No.2020-18346 and PWS No.2021-19356 is finalized, if not exempted as per RTI act.

With these directions instant appeal stands disposed off.

In case, appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
