ORDER

The appellant has preferred 1st appeal dated 31.08.2024 against the disposal of her RTI application dated 29.07.2024 by CPIO/Hqrs with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application dated 29.07.2024 had sought action taken report on her complaint against Lally Motors Jalandhar and others and why no FIR is registered on her given complaints.

COMMENTS OF CPIO/Hqrs :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was received to supply the requisite information and the same was denied to the appellant as per the provisions of section 2 (f) of RTI Act vide no. 222/CPIO/Hqrs/Online RTI-24 dated 28.08.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought action taken report on her complaint against Lally Motors Jalandhar and others and why no FIR is registered on her given complaints.

In reply, CPIO/Hqrs had denied the requisite information as per the provisions of section 2(f) of RTI Act.

So far as the present appeal is concerned, CPIO/Hqrs has inadvertently denied the sought information to the appellant as per the provisions of section 2 (f) of RTI Act. Therefore, CPIO/Hqrs is hereby directed to reconsider the RTI application and take necessary action strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
