ORDER

This is an order in connection with First Appeal preferred by of Sh. Naresh Kumar, R/o Flat No. 89, City of dreams -2, SBP, Sector -116, Mohali, Punjab under RTI Act 2005, received in this office on 05.03.2024 against the disposal of his RT Application dated 29.01.2024 by CPIO/Establishment & CPIO/PEB.

Facts:-

2. Vide RTI application dated 29/01/2024, the appellant had sought information in 04 different points, out of which point no. 03 & 04 were dealt by CPIO/PEB & CPIO/Establishment, which are as under:-

Point No. 3:- The copy of Retirement order Sh. Satyanarayan Singh, Sub. Inspector.

Point No. 4:- The copy of order of posting of Sh. Satyanarayan Singh, SI, in Women Police Station Sector -17, Chandigarh.

3. The appellant is not satisfied with the information supplied by the CPIO/PEB. and CPIO/Establishment against his RTI application and has filed the

instant appeal mentioning therein that the information has not been furnished on the ground that the Belt Number has not been mentioned in the application is extensively perplexing to any reasonable person.

4. The comments of CPIO/PEB. and CPIO/Establishment were sought, vide No D-238-39/RTI/SP/Hqrs. dated 05.03.2024. The comments received from the CPIO's are as under:-

Comments of CPIO/PEB.

CPIO/PEB. submitted that the said RTI application was transferred by CPIO-cum/DSP/W&CSU., vide no. 34/UT/DSP/W&CSU dated 06.02.2024, to provide part information u/s 6(3) of Right to Information Act 2005 with respect to point no. 4.

The applicant have not mentioned complete particular i.e. Belt no in his RTI application. Without complete particulars this office is unable to provide such information as desired and the same was intimated to the applicant vide No. RTI-05/PEB/Branch dated 21.02.2024.

Comments of CPIO/Establishment

CPIO/Establishment submitted that the applicant requested for information regarding copy of Posting, Relieving & Retirement orders of Sub Inspector Satyanarayan. As per report of concerned branch i.e. E-1, the requisite information with regard to point No. 03 (i.e. copy of retirement order) cannot be traced without belt number of said official. Hence the same reply was sent to the applicant vide office letter No. 37/RTI-24/CPIO/Estt./UT/8161 dated 22.02.2024.

DECISION

5. I have considered the appeal filed by the appellant viz-a-viz comments of CPIO/PEB and CPIO/Establishment. The undersigned being First Appellate Authority is not satisfied with the reply sent by the CPIOs. Therefore, both CPIOs are hereby directed give a fresh reply to the applicant as per norms of RTI Act 2005. The appeal is hereby disposed of, accordingly.
