

**THE SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE AUTHORITY-
ACCTS. & ESTABLISHMENT BR., UNDER RIGHT TO INFORMATION ACT,
2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on the First Appeal dated 29.03.2022, preferred by Sh. Yetinder Singh, VPO Jhanjeri, Tehsil Kharar, Distt. Mohali, Punjab under RTI Act 2005, received in this office against the disposal of his RTI Application dated 24.02.2022.

(2) The appellant, vide his application dated 24.02.2022 under RTI Act 2005, had requested Sr. Superintendent of Police, PHQ, Sector-09, U.T., Chandigarh, to supply him some information in 04 points related to LTC availed by him but encashment of 10 days EL not received in his account. Incharge, Public Window (PHQ)-cum- CAPIO/PHQ transferred the RTI application to CPIO/Establishment, vide letter No. 186/RTI/CAPIO (PHQ)/UT/PWS dated 28.02.2022, for disposal at his own level. CPIO/Accounts, further disposed of the RTI application, vide No. 32/RTI-22/CPIO (Estt.)/UT/12582 dated 04.03.2022, supplying part information on point No. 03 and also transferred the point No. 01 & 04 to CPIO/Accounts & Proc., vide No. 32/RTI-22/CPIO(Estt.)/UT/11407 dated 04.03.2022. DSP/HQs.-cum-CPIO/Accounts had disposed of the same, vide No. 19/RTI/CPIO (Accts)/2022/UT/10606 dated 21.03.2022.

(3) The appellant is not satisfied with the information supplied to him, has filled instant appeal aggrieving that my both CPIOs has failed to provide satisfactory information on 04 points. The comments of DSP-cum-CPIO/Accounts and CPIO/Establishment have been called for.


(4) I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Accounts and CPIO/Establishment. The appellant, through his RTI application, had sought information in 04 points, mentioning therein that he has availed LTC for the block year 2018-21, but he haven't received encashment of 10 days EL in his account so far. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-

The appeal is hereby disposed of accordingly.

The appellant, if not satisfied with the disposal of appeal in the manner as above can file second appeal to the Hon'ble Chief Information Commission, CIC Bhawan, Baba Gangnath Marg, Munrika, New Delhi-110067 within a period of 90 days.
