ORDER

The appellant has preferred instant 1st appeal against the disposal of her RTI application dated 18.07.2022 by CPIO/Central with the contentions that the proper information was not provided to her.

INFORMATION SOUGHT IN RTI APPLICATION :-

The appellant vide her RTI application dated 18.07.2022 had sought copies of DDR Nos. 40 & 47 dated 12.01.2022, Police Post Sector 22/PS Sector 17, Chandigarh.

COMMENTS OF CPIO/Central: -

Comments of CPIO/Central have been obtained who submitted that RTI application of the appellant was received in his office by hand on 18.07.2022 to supply the copy of DDR Nos. 40 & 47 dated 12.01.2022, Police Post Sector 22/PS Sector 17, Chandigarh. After obtaining the requisite information i.e. copies of DDR No. 40 dated 12.01.2022 PP Sector 22 and DDR No. 47 dated 12.01.2022 PS Sector 17, the same were provided to the appellant vide letter no. 202/RTI-22/CPIO-Central/UT dated 01.08.2022. Now, vide the instant appeal appellant has sought copy of DDR no. 42 dated 25.11.2020 and DDR No. 56 dated 29.11.2021 which she neither sought vide her RTI application dated 18.07.2022 nor supplied by CPIO/Central.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant vide her RTI application dated 18.07.2022 had sought copies of DDR Nos. 40 & 47 dated 12.01.2022, Police Post Sector 22/PS Sector 17, Chandigarh.

In reply, CPIO/Central has supplied the requisite information i.e. copies of DDR Nos. 40 dated 12.01.2022, PP Sector 22 and DDR No. 47 dated 12.01.2022 PS Sector 17 to the appellant on dated 01.08.2022. Thus there is neither any delay nor any denial on the part of CPIO/Central.

So far as the instant appeal is concerned, appellant sought additional information i.e. copies of DDR no. 42 dated 25.11.2020 and DDR no. 56 dated 29.11.2021 which she never sought vide her RTI application dated 18.07.2022.

Now, for the satisfaction of the appellant and to uphold the spirit of RTI Act, CPIO/Central is directed to supply the copies of DDR no. 42 dated 25.11.2020 and DDR no. 56 dated 29.11.2021, if the same relates to the appellant and not exempted under RTI act.

With these directions instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
