ORDER

The appellant has preferred this instant 1st appeal dated 11.09.2024 against the disposal of his RTI application dated 22.08.2024 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information on 21 points regarding lady police official Sudesh No. 3364/CP i.e. place of posting & rank, record of posting in police station, location on dated 13.06.2024, details of duty of may & June 2024, details of leave availed on dated 13.06.2024, if availed, details of sanctioning authority of leave, if availed, reason for not being present on duty, details of officer authorized her to return to duty after 13.06.2024, details of mobile number on her Aadhar card & copy of CDR, details of house no. 479/14, details of house mentioned in income tax and government documents, details of all persons residing in her house, details of rules where allowances are not given to person who is residing with their partner, details of rules where allowances are provided to a person who is residing with their partner, details of source of income, salary slip from date of joining, details of leaves availed & absent record, copy of service book, details of her husband in service record, details of persons dependent on her and copy of rules where after the death of husband, she marries again then will she be dependent on him.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information. Only, point no. 09 was found related with the office. Accordingly, report from I/C MTMC was obtained who reported that sought information is personal in nature and third party. Hence, the same was denied to the appellant as per the provisions of section 8 (1) (j) of RTI Act, vide no. 51/RTI/DSP/Admn dated 27.08.2024.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information on 21 points regarding lady police official

Sudesh No. 3364/CP i.e. place of posting & rank, record of posting in police station, location on dated 13.06.2024, details of duty of may & June 2024, details of leave availed on dated 13.06.2024, if availed, details of sanctioning authority of leave, if availed, reason for not being present on duty, details of officer authorized her to return to duty after 13.06.2024, details of mobile number on her Aadhar card & copy of CDR, details of house no. 479/14, details of house mentioned in income tax and government documents, details of all persons residing in her house, details of rules where allowances are not given to person who is residing with their partner, details of rules where allowances are provided to a person who is residing with their partner, details of source of income, salary slip from date of joining, details of leaves availed & absent record, copy of service book, details of her husband in service record, details of persons dependent on her and copy of rules where after the death of husband, she marries again then will she be dependent on him.

In reply, CPIO/Admn reported that only point no. 09 i.e. details of mobile number according to her Aadhar Number and provide CDR report of the same, found relating with the CPIO and the same was denied to the appellant as per the provisions of section 8 (1) (h) of RTI Act.

Now, as far as appeal is concerned, CPIO/Admn has advertently disposed of the RTI application without going through all the points of RTI Application. Hence, CPIO/Admn is hereby directed to reconsider the RTI application of the appellant and provide point wise reply to the appellant.

Furthermore, Nodal Officer CPIO/Hqrs has transferred the RTI application to CPIO/Admn, CPIO/PEB, CPIO/Establishment and CPIO/Accounts without mentioning the points pertaining/related with them for proper disposal of the RTI application. Hence, Nodal Officer CPIO/Hqrs is hereby directed to transfer the RTI application after thorough perusal of RTI application and by mentioning the points relating to the concerned CPIOs.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
