This order online in **First** Appeal bearing PODEP/A/E/24/00019 dated 08/03/2024, preferred Priyanka R/o 322 Durga Nagar A, Ambala City, Ambala, Haryana under RTI Act 2005, received in office through online RTI Request & Appeal Management Information System (RTIagainst the disposal of her RTI Application bearing PODEP/R/E/24/00093 dated 09/02/2023 being dealt by CPIO/Trq. Recruitment.

## Facts:-

2. Vide RTI application dated 09/02/2024, the appellant had sought information w.r.t. recruitment of ASI (executive) in Chandigarh Police 2023, which is as under :-

"I did Chandigarh Police ASI exam (executive) 44 posts in 2023. My roll no. was 2780300919 with name Priyanka D/o Naresh Kumar. Kindly provide me question paper with booklet series C. My question booklet no. was 270935. Kindly provide me question paper according with booklet series no. Please provide me question paper booklet series no. C."

3. The appellant, is not satisfied with the information supplied by the DSP-Cum-CPIO/Rec. & Trg. against her application and has filed the instant

mentioning therein that "I did Chandigarh Police ASI exam (executive) 44 posts in 2023. My roll no. was 2780300919 with name Priyanka D/o Naresh Kumar. Kindly provide me question paper with booklet series C. My question booklet no. was 270935. Kindly provide me question paper according with booklet series no. Please provide me question paper booklet series no. C. But instead of that department provide me wrong question paper. kindly provide me accurate information & question paper of ASI Chandigarh Police exam paper with booklet series c as details mentioned above."

4. The Comments in this appeal were sought from DSP-Cum-CPIO/Rec. & Trg, who intimated that the appellant vide her RTI application had requested to supply her question paper with booklet series C for the post of ASI executive in Chandigarh Police exam-2023, the requisite information was sought from the In-charge Recruitment Cell and the was provided to the applicant in time hound manner, vide office letter no. RTI-11/CPIO/Rec. & Trg. dated 04.03.2024. But the earlier information provided to the applicant pertains to the post of constable (executive) instead of ASI (executive) in Chandigarh Police, given inadvertently to the applicant. The actual information sought by the applicant i.e. booklet series "C" for the post of ASI Executive in Chandigarh Police -2023 may be provided to the appellant.

## **DECISION**

The undersigned has gone through the appeal filed by the appellant viz-a-viz comments of CPIO-cum-DSP/Trg. & Rectt. From the perusal of RTI application & comments of CPIO, it's found that the information supplied to the applicant is not correct. Therefore, CPIO/Trg & Rectt. is hereby directed to supply the correct information within 5 days under the receipt to this office. The appeal is hereby disposed off accordingly.
