ORDER

The appellant has preferred this instant 1st appeal dated 13.09.2024 against the disposal of his RTI application dated 27.08.2024 by CPIO/Admn with the contentions that requisite information was not provided to him.

Information sought vide RTI application :-

The appellant vide his RTI application had sought information regarding reinvestigation report of complaint bearing no. ICMS/2024/017693.

COMMENTS OF CPIO/Admn :-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the requisite information. Accordingly, requisite information was obtained from I/C HAC who reported that complaint in question is not available in record. As per the ICMS portal, RTI application was transferred to CPIO/PCC being the custodian of the requisite information vide no.73/CPIO/Admn/RTI-2024 dated 11.09.2024.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Admn vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought information regarding re-investigation report of complaint bearing no. ICMS/2024/017693.

In reply, CPIO/Admn transferred the RTI application of the appellant to CPIO/PCC being custodian of the requisite information.

Now, as far as appeal is concerned, from the perusal of the RTI application, CPIO reply and contents of 1st appeal, CPIO has inappropriately disposed of the RTI application on dated 03.09.2024, on online portal denying the requisite information to the appellant as per the provisions of section 8 (1) (h) of RTI Act and again the same RTI application was transferred to CPIO/PCC vide no. 73/RTI/DSP/Admn/RTI-2024 dated 11.09.2024, in physical mode. Therefore, CPIO/Admn is hereby directed to reconsider the RTI

application and provide the requisite information, if the same relates with the CPIO, strictly as per the provisions of RTI Act.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
