**ORDER**

The appellant has preferred 1<sup>st</sup> appeal against the reply of CPIO/Central in connection with his RTI application with the contentions that requisite information was not supplied to him. The appeal was diarized vide No. 83/UT/RTI/FAA/SSP dated 17.08.2021 for further proceeding under RTI Act.

**INFORMATION SOUGHT IN RTI APPLICATION:-**

The appellant has sought information on 4 points pertaining to ASI Satish Kumar No. 1514/CHG i.e. total No. cases in which he is complainant, Investigating Officer, recovery affected being IO etc.

**COMMENTS OF CPIO/CENTRAL: -**

CPIO/Central submitted that appellant has sought information through RTI application. Thereafter, report from all the SHOs of Central Division was obtained and therefore, requisite information was denied to the appellant u/s 8(1)(j) of RTI Act being third party information. Appellant was informed in this regard vide No. 224/RTI-21/CPIO-Central dated 12.07.2021.

**DECISION:-**

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/Central vis-à-vis material available on record which revealed that appellant had sought information on 4 points pertaining to ASI Satish Kumar No. 1514/CHG i.e. total No. cases in which he is complainant, Investigating Officer, recovery affected being IO etc.

Insofar appeal is concerned, it is clear that appellant has sought information in figures with respect to ASI Satish Kumar i.e. total No. cases in which he is complainant, Investigating Officer & 2<sup>nd</sup> IO, recovery affected being IO by him etc. which can be supplied as per RTI Act. Hence, instant appeal is hereby disposed of with the direction to CPIO/Central to supply point-wise information (in figure only) to the appellant as per RTI Act.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
