### ORDER

The appellant has preferred 2<sup>nd</sup> appeal under Right to Service Act, 2011 regarding disposal of complaint bearing No. ICMS/2023/012905 dated 27.05.2023 filed against Sandeep Singh. The instant appeal was diarized vide No. R-10 & 11/UT/RTSA/SSP/SAA dated 15.11.2023 for further proceeding under RTS Act.

## Comments of SHO-36-cum-Desginated Officer: -

Comments of SHO-36 have been obtained who submitted that the matter pertains to a complaint bearing No. ICMS/2023/012905 dated 22.05.2023 filed by the petitioner Mr. Ram Diya Attri against Mr. Sandeep Singh (coach) alleging corruption in selection for Junior under 14 trials of Chandigarh Football Academy which was received in his office for enquiry. During enquiry, statements of all parties were recorded and complaint in question was submitted to senior officers after completion of enquiry and the same is now consigned to HAC Branch after finalizing by senior officers.

#### **DECISION:-**

I have gone through the complaint of the complainant, instant petition of the petitioner, comments of Designated Officer-cum-SHO PS Sector 36 vis-à-vis material available on record thoroughly which revealed that the petitioner had filed a complaint vide No. ICMS/2023/012905 dated 22.05.2023 against Mr. Sandeep Singh (coach) alleging corruption in selection for Junior under 14 trials of Chandigarh Football Academy.

As per comments of Designated Officer-cum-SHO PS Sector 36 and present status of the complaint it has been established that necessary/appropriate action has already been taken in the matter and complaint has already been consigned to record in HAC Branch after the finalization of the enquiry.

Now, as far as this instant appeal is concerned, the needful has already been done and the complaint is consigned with HAC Branch after the finalization. Therefore, no more action is required to be taken in the matter and the instant appeal is filed, accordingly.
