ORDER

The appellant has preferred 1st appeal through online RTI portal vide No. PODEP/A/E/22/00099 dated 23.08.2022 against the disposal of his RTI application bearing No. PODEP/R/E/22/00610 dated 08.08.2022 by CPIO/East with the contentions that incomplete, misleading or false information have been provided to him.

INFORMATION SOUGHT IN RTI APPLICATION:

The appellant vide his RTI application dated 08.08.2022 had sought copy of complaint and action taken by Chandigarh Police on two complaint which was sent by him through e-mail to public window mail-id ppwphq-chd@nic.in from mail id arrivesafe@gmail.com. These complaints were registered vide No. ICMS/2022-004785 dated 28.07.2022 and PWS No.2022-06436 dated 29.03.2022.

COMMENTS OF CPIO/EAST: -

Comments of CPIO/East have been obtained who submitted that RTI application of the appellant was received in his office through online RTI portal vide. No.PODEP/R/E/22/00610 dated 08.08.2022 in which appellant sought copy of complaint and action taken by Chandigarh Police on two complaint which was sent by him through e mail to public window mail id ppwphq-chd@nic.in from mail id arrivesafe@gmail.com. Further, these complaints were registered vide No. ICMS/2022-004785 dated 28.07.2022 and PWS No.2022-06436 dated 29.03.2022. Accordingly, after obtaining report from SHO PS-26, point wise reply was sent to the appellant vide letter No. 229-RTI/CPIO/East/ dated 22.08.2022. Vide this letter it

was conveyed that "complaint bearing No. ICMS/2022-004785" dated 28.07.2022 is under enquiry with PS-26 and complaint bearing PWS No.2022-06436 dated 29.03.2022 has been sent to senior officer on 16.08.2022 after enquiry for finalization". However copies of both these complaints were supplied to the appellant.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/East vis-à-vis material available on record which revealed that appellant vide his RTI application dated 08.08.2022 had sought information pertaining to two complaints i.e No. ICMS/2022-004785 dated 28.07.2022 and PWS No. 2022-06436 dated 29.03.2022. Whereas, CPIO/East has already intimated to the appellant that complaint bearing No. ICMS/2022-004785 dated 28.07.2022 is under enquiry with PS-26 and complaint bearing PWS No.2022-06436 dated 29.03.2022 has been sent to competent authority on 16.08.2022 after enquiry for finalization. Moreover, copies of both these complaints were supplied to the appellant by CPIO/East. So, it clear that CPIO/East appropriately disposed off the RTI application of the appellant by supplying him copies of complaints and informing the action taken upon his complaints.

However, for achieving the objective of RTI Act as well as for the satisfaction of the appellant, CPIO/East is directed to supply the action taken report to the appellant again as and when inquiry into the complaint No. ICMS/2022-004785 dated 28.07.2022 and PWS No.2022-06436 dated 29.03.2022 is finalized, as per provisions of RTI Act.With these directions instant appeal stands disposed off.

In case, appellant is not satisfied with the disposal of his appeals, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
