

**THE SENIOR SUPERINTENDENT OF POLICE HQs.-CUM-APPELLATE
AUTHORITY-ESTABLISHMENT, UNDER RIGHT TO INFORMATION ACT,
2005.**

Order on First Appeal u/s 19 RTI Act.

This is an order on an online First Appeal bearing no. PODEP/A/E/23/00022 dated 02/03/2023, preferred by Sh. Abhishek R/o # House NO. 1430 -A, Sector 39-B, Chandigarh, under RTI Act 2005, received in office online through RTI Request & Appeal Management Information System (RTI-MIS), against the disposal of his online RTI Application bearing No. PODEP/R/E/22/00979 dated 11/12/2022 by CPIO/Establishment.

(2) The appellant, vide his application dated 11/12/2022 under RTI Act 2005, had requested CPIOs to supply him some information in 04 points related to recruitment in 1988 by Chandigarh Police in Communication Wing. Nodal Officer/PHQ has transferred the application to DSP-cum-CPIO/Establishment for its proper disposal. CPIO/Establishment disposed of the RTI application on 09/01/2023, vide No. 223/RTI-22/CPIO(Estt.)/U.T., 1281.

(3) The appellant, not satisfied with the information supplied by the CPIO against his RTI application and has filed the instant online appeal to provide right information.

(4) Comments of CPIO have been called for. I have gone through the RTI appeal, vis-a-vis facts of the RTI application & comments by CPIO/Establishment. The information sought by the appellant, supplied by the CPIO, grievance of the appellant and the order/decision of the undersigned being first appellate authority is given below:-


