ORDER

The appellant has preferred 1st appeal (bearing No. PODEP/ A/E/21/00068 dated 20.08.2021) against the reply/order of CPIO/East & South in connection with his RTI application (bearing No. PODEP/ R/E/ 21/00440/1 dated 06.08.2021) with the contentions that requisite information was not supplied to him. The instant appeal was diarized vide No. 87/UT/RTI/FAA/SSP dated 25.08.2021 for further proceeding under RTI Act.

INFORMATION SOUGHT IN RTI APPLICATION:-

Appellant had sought information on 5 points regarding orders issued by DM Chandigarh for sealing of Bank ATM without security guard etc.

COMMENTS OF CPIO/EAST: -

CPIO/East submitted that application of the appellant was received online for supplying requisite information. On perusal of RTI application, only 2 points found related with them. Thereafter report from all SHOs of Sub-Division East have been sought regarding orders issued by DM Chandigarh for sealing of Bank ATM without security guard. All SHOs reported that no such order has been received in their respective police

station. Subsequently, appellant was informed in this regard vide No. 288-RTI/CPIO/East dated 17.08.2021.

COMMENTS OF CPIO/SOUTH: -


CPIO/South submitted that application of the appellant was received online for supplying requisite information. Thereafter report from all SHOs of Sub-Division East have been sought regarding orders issued by DM Chandigarh for sealing of Bank ATM without security guard. All SHOs reported that no such order has been received in their respective police station. Subsequently, appellant was informed in this regard vide No. 434/CPIO/South dated 28.08.2021.

DECISION:-

I have gone through the contents of RTI application & appeal of the appellant, comments of CPIO/East & South vis-à-vis material available on record which revealed that appellant had sought information on 5 points regarding orders issued by DM Chandigarh for sealing of Bank ATM without security guard etc.

Insofar as appeal is concerned, from the reply of CPIOs it is clear that appellant was informed with respect to his RTI application that no order of DM, Chandigarh was received regarding sealing of Bank ATM Sector 48A mini market without security guard, moreover, no ATM has been sealed by PS-49 Hence, no more action is required in the instant appeal, accordingly the same is hereby disposed of.

In case, the appellant is not satisfied with the disposal of appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
