ORDER

The appellant has preferred 1st appeal dated 28.07.2023 against the disposal of his RTI application dated 19.06.2023 (21.06.2023) by CPIO/Hqrs with the contentions that requisite information were not provided to him.

Information sought vide RTI application:-

The appellant vide his RTI application dated 20.06.2023 had sought action taken report and copies of complaints filed against him by Mr. Ravi Shankar Mehndiratta i.e. complaints bearing Nos. ICMS/2022/006379, 006704, 011883, 016849, 005701 & 007683.

COMMENTS OF CPIO/Hars :-

CPIO/Hqrs vide his comments submitted that RTI application of the appellant was transferred in his office from CPIO/East to supply the information regarding complaints bearing No. ICMS/2022/006379, 006704, 011883, 016849, 005701 & 007683 filed against the appellant by Mr. Ravi Shankar Mehndiratta. Thereafter, requisite information was obtained from I/C CRU who reported that complaints in question are under consideration for finalization. Hence, sought information was denied to the applicant as per provisions of section 8(1)(h) of RTI Act, 2005 vide letter No. 380/CPIO/Hqrs/RTI-2023, D-522 Dated 17.07.2023.

DECISION:-

I have gone through the contents of RTI application, appeal of the appellant, comments of CPIO/Hqrs vis-à-vis material available on record which revealed that the appellant vide his RTI application had sought action taken report and copies of complaints

filed against him by Mr. Ravi Shankar Mehndiratta i.e. complaints bearing Nos. ICMS/2022/006379, 006704, 011883, 016849, 005701 & 007683.

In reply, CPIO/Hqrs had denied the requisite information to the appellant u/s 8(1)(h) of RTI Act as the complaints in questions were under consideration at that stage.

So far as the present status of the complaints are concerned, the same are still under consideration for finalization. Hence, enquiry report cannot be provided at this stage, however, copy of complaints can be provided to the appellant. Accordingly, CPIO/Hqrs is hereby directed to provide the copy of complaints to the appellant in accordance with RTI act and he is further directed to supply the action taken report or enquiry report to the appellant as per RTI act after finalization of enquiry and if no case FIR is registered on these complaints.

With these observations, instant appeal stands disposed off.

In case, the appellant is not satisfied with the disposal of his appeal, he can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
