ORDER

The appellant has preferred her 1st appeal dated 14.09.2024 against the disposal of her RTI application dated 05.09.2024 by concerned CPIOs with the contentions that requisite information was not provided to her.

Information sought vide RTI application :-

The appellant vide her RTI application dated 05.09.2024 had sought information on 03 points regarding action report on PMOPG/E/2024/0134221 i.e. commercial utilization of biological resources from UT, Chandigarh Biodiversity Board, performing animals from UT Chandigarh Animal Welfare Board and permission to protest in front of Rock Garden.

COMMENTS OF CPIO/Central:-

CPIO/Central vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned SHOs who reported that no such NOC regarding permission to protest was provided and applicant was apprised, accordingly.

COMMENTS OF CPIO/South:-

CPIO/South vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned SHOs who reported that no such NOC regarding permission to protest was provided and applicant was apprised, accordingly.

COMMENTS OF CPIO/South-West:-

CPIO/South-West vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned SHOs who reported that sought information does not relates with CPIO and applicant was apprised, accordingly.

COMMENTS OF CPIO/North-East:-

CPIO/North-East vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information

was obtained from concerned SHOs who reported that sought information does not relates with CPIO and applicant was apprised, accordingly.

COMMENTS OF CPIO/Admn:-

CPIO/Admn vide his comments submitted that RTI application of the appellant was received in his office to supply the information. Thereafter, requisite information was obtained from concerned branch who reported that sought information does not relates with CPIO and applicant was apprised, accordingly.

DECISION :-

I have gone through the contents of RTI application, appeal of the appellant, comments of concerned CPIOs vis-à-vis material available on record which revealed that the appellant vide her RTI application had sought information on 03 points regarding action report on PMOPG/E/2024/0134221 i.e. commercial utilization of biological resources from UT, Chandigarh Biodiversity Board, performing animals from UT Chandigarh Animal Welfare Board and permission to protest in front of Rock Garden.

In reply, concerned CPIOs have provided the available sought/requisite information with them to the appellant.

Now as far as appeal is concerned, appellant is not satisfied with the information provided to him. However, CPIOs have appropriately disposed off the RTI application by providing the available information to the appellant. Hence, no more action is required to be taken on this instant 1st appeal as requisite information has already been provided to the appellant.

With these observations, instant appeal stands disposed off accordingly.

In case, the appellant is not satisfied with the disposal of her appeal, she can file second appeal before the Hon'ble CIC, CIC Bhawan, Baba Gangnath Marg, Munirka, New Delhi-110067 under the RTI Act within 90 days.
